

BAC Achievement Award – Criteria

Each year, the Beautification Advisory Commission will select a Phoenixville resident owner and a Phoenixville business property owner to receive an award that recognizes their significant impact and contributions to the cultural environment and natural landscape in the Borough of Phoenixville.

The BAC will appoint an award committee composed of three members of the BAC and two members of Borough Council to review nominations for the Achievement Award. The committee will send its recommendations to the BAC for final approval.

No members of the current BAC will be eligible to receive the award in a given year.

All committee and BAC discussions regarding the selection of Achievement Award recipients will remain confidential.

Categories for the award might include the following:

1. A significant improvement of a blighted property
2. An aesthetic enhancement of an existing streetscape or park
3. The creation and implementation of a new beautification initiative
