AN ORDINANCE AMENDING CHAPTER 15 “MOTOR VEHICLES AND TRAFFIC PART 4 “GENERAL PARKING REGULATIONS”, SECTION 15-402 BY CHANGING THE NUMBER OF “PARKING PROHIBITED AT ALL TIMES IN CERTAIN LOCATIONS”, SECTION 15-403 BY CHANGING THE NUMBER OF “PARKING PROHIBITED IN CERTAIN LOCATIONS CERTAIN DAYS AND HOURS”AND SECTION 15-406 BY CHANGING THE NUMBER OF “HANDICAPPED PARKING ZONES” IN THE BOROUGH OF PHOENIXVILLE, CHESTER COUNTY, PENNSYLVANIA

The Council of the Borough of Phoenixville, Chester County, Pennsylvania hereby ORDAINS that:

**SECTION 1.**

Chapter 15, “Motor Vehicles and Traffic,” Part 4, “General Parking Regulations,” Section 15-402, “Parking Prohibited at All Times in Certain Locations,” is hereby amended as indicated by the black line and strikeout interlineations below, with strikeout indicating deletions of language and underlined interlineations indicating insertions of language:

<b>Street</b>	<b>Side</b>	<b>Between</b>
<u>Starr Street</u>	<u>West</u>	<u>At a point 30 feet south of the southwest corner of Church Street on the west side of Starr Street. A <i>No Parking</i> sign shall be placed with the sign facing south.</u>
<u>Starr Street</u>	<u>East</u>	<u>At a point 460 feet south of the southeast corner of Bridge Street on the east side of Starr Street. A <i>No Parking Corner to Here</i> sign shall be placed with the sign facing north.</u>

**SECTION 2.**

Chapter 15, “Motor Vehicles and Traffic,” Part 4, “Traffic Regulations,” Section 15-406, “Handicapped Parking Zones,” is hereby amended as indicated by the black line and strikeout interlineations below, with strikeout indicating deletions of language and underlined interlineations indicating insertions of language:

<b>Street</b>	<b>Side</b>	<b>Location</b>
<u>Gay Street</u>	<u>West</u>	<u>Beginning at a point 135 feet south of the southwest corner of Fourth Avenue on the west side of Gay Street; thence from said point of beginning to a point 20 feet in an northerly direction from the point and place of beginning. The sign should face north and a <b><i>Reserved Penalties</i></b> sign should be mounted below it.</u>
<u>E. High Street</u>	<u>West</u>	<u>Beginning at a point 260 feet east of the northeast corner of Dayton Street on the east side of E. High Street; thence from said point of beginning to a point 20 feet in an easterly direction from the point and place of beginning. The sign should face east and a <b><i>Reserved Penalties</i></b> sign should be mounted below it.</u>
<u>Nutt Road</u>	<u>North</u>	<u>Beginning at a point 262 feet west of the northwest corner of Buchanan Street on the north side of Nutt Road; thence from said point of beginning to a point 20 feet in an easterly direction from the point and</u>

place of beginning. The sign should face east and a **Reserved Penalties** sign should be mounted below it.

**SECTION 3.**

If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, parts, or section hereof. It is hereby declared as the intent of the Borough Council that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, part or section thereof not been included herein.

**SECTION 4.**

All Ordinances or parts of Ordinances conflicting or inconsistent herewith are hereby repealed.

**SECTION 5.**

This Ordinance shall become effective upon enactment as provided by law.
