Borough Offices & Facilities:

Is the Borough Office Open to the public?

In the interest of public health, the Borough of Phoenixville has implemented measures to mitigate the exposure to COVID-19. Borough Hall and the Civic Center are closed to public access until further notice.

Are the Borough Parks & Schuylkill River Trail open?

Our parks and the trail remain open. However, we have posted and closed down the use of any playground or workout equipment. Bathrooms and water fountains are also not in use. Social Distancing and PPE's are strongly encouraged even while outdoors.

Is the Compost Site Open?

Yes Monday-Friday 7:00 am to 3:00 pm, No weekend hours until further notice.

Loose or biodegradable bags of yard waste can be dropped off by the resident. Site will be closed on Monday, May 25 due to Memorial Day Holiday.

Are you Collecting Bulk Items?

The scheduling and pickup of bulk items have been suspended until further notice.

Are you Collecting Metal Items?

The scheduling and pickup of metal items have been suspended until further notice.

How can I Recycle Electronics?

Retrievr is a FREE service for residents to use that will take electronics and clothes and recycle them.

New appointments can be scheduled at any time. Please have patience during these first few weeks as we open new pickup slots to meet demand.

As we resume serving your community, our top priority is the health of our customers and employees. Our service was already relatively contact-free, and we have taken a few additional steps you might notice to make it even safer for everyone involved:

- All pickups will be contactless
 - If you requested that we ring your bell, we will reach out to confirm that you have the ability to leave your items on your porch or outside your garage.
 - For your safety and the safety of our driver, we are suspending the **Ring** option and ask that you not meet our driver at your door
- All employees must pass a temperature check (under 100.4) before reporting for work
- Employees feeling ill are required to stay home
- Drivers will disinfect the Retrievr truck before beginning their route
- Drivers will carry cleaning and disinfectant supplies in Retrievr trucks to disinfect collected items
- Drivers will use hand sanitizer after each collection
- Retrievr provides drivers with face masks, safety glasses, and gloves

On April 23, 2020 the Wolf Administration Issued Guidance as Construction Industry Prepares to Resume Work May 1. To protect Borough Staff, the Borough will have limited personnel available beginning Monday, May 4 to issue permits. Further to provide additional protection of Staff while out on job sites, inspections will be limited. In the interest of individual safety, the Borough will work with construction firms to the greatest extent possible but reserves the right to pace the issuance of permits and inspections.

Submitting a Building Permit

Make sure to include as much information as possible on the work to be performed, contact information for yourself and the contractor, should the office have questions. Emails are the best means of communication right now and all information should be directed to codes@phoenixville.org.

You may need to provide drawings or plans for the project please attach them along with the completed permit to codes@phoenixville.org. If the plans are too large or codes needs a hard copy they will contact you and provide instructions on how to get the items to us.

Once the permit has been reviewed and is approved you will be contacted to make payment for the permit so it can be issued.

General Questions

Are you accepting new Right to Know Requests?

The Borough of Phoenixville closed its offices on March 16, 2020 and remains closed until further notice due to the COVID-19 National Emergency. In accordance with the Right-to-Know Law, if an agency is closed on a given day, that day is not a “business day” and does not count toward the five business days referenced in Section 901 of the RTKL, which governs the time period under which an agency must respond to a request.

We appreciate your consideration and patience during this current emergency. Once the Borough of Phoenixville reopens its offices, we will accept the Right-to-Know request and begin processing it accordingly.
